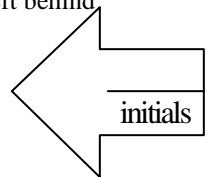

### SDFC Code of Conduct

The Sand Dragons Futbol Club ("the club") is committed to safety and sportsmanship for all members, our families and our spectators on the sidelines. As most to the responsibility lies in the actions of each player and as a player in and for this club you must abide by the rules here listed and those not listed so as to prevent injury to another person, any action (legal or league board) against the club, embarrassment to the club or fines to the club. As a member of the club, I agree to abide by these rules.

- ▶ I shall refrain from profanity on and off the field, whether directed at any other player, official or spectator. I shall also refrain from vulgarity and disgusting behavior as other players and their families may be offended.
- ▶ In the spirit of clean sportsmanship I will play fair within the spirit of the game and with no intent to injure anyone.
- ▶ I shall not participate in illegal activities that could in any way reflect negatively on the club or it's members.
- ▶ I shall not fight on the field or enter the field to join a fight as this could result in my teams' ejection from the league. I will try to prevent fights or break up fights if they occur.
- ▶ I will follow the instructions of club officers and my team captain when asked to substitute, leave the field of play, calm down or depart the area.
- ▶ I will not argue with the referee or the team captain either on or off the field.
- ▶ I will leave the field only after I have cleaned the area used and collected any items that were accidentally left behind by other members of the club.
- ▶ **I accept and understand that the club may provide uniforms and equipment, and that the jersey and equipment is the property of the club and must be returned at the end of each season or on request. I freely take responsibility for club property while it is in my possession. If any such property is damaged or lost while in my care, I have the full responsibility to replace it.**

### SDFC Notice of Waiver

In consideration for the privilege of membership in the Sand Dragons Futbol Club and the opportunity that it provides, I...

- ▶ Am responsible for any medical bills that I may incur as a result of injury while participating in club related activities and as such I will obtain or purchase adequate health or other insurance for myself incase such an injury does occur. At my own discretion, I may also choose to carry disability insurance. I further realize that the club and any facility it may use has no responsibility for providing insurance of any kind to cover me in any way or to cover my actions.
- ▶ I release, waive, discharge and covenant not to sue the Sand Dragons Futbol Club or any of it's members to include it's directors, captains, coaches or other members of the organization. I hereby release from any demand, loss or damage for any reason excepting willful negligence or misconduct.
